Minutes of April 28, 2026 Fire Commission Meeting Fire Station #1, 1111 Fox Street, Mukwonago WI 53149

1. Meeting was called to order at 5:02 pm by President Dubey.
2. Roll call
 - 2.1. Village: Commissioners Grant and Roberts present, Gregory absent; Liaison Johnson present.
 - 2.2. Town: Commisioners Dubey and Boucher present; Liaison Gilboy absent.
 - 2.3. Chief Stien present.
3. Announcement of closed session pursuant to Wis. Stats. 19.85(1)(c) *for the purpose of considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility*; specifically, regarding resignations, part-time Paid-On-Call (POC) and Paid-On-Premise (POP) candidates, and interviews for full-time Firefighter/EMT/Paramedic candidates. (two vacancies)
4. Dubey moved to approve minutes of March 3, 2026 as presented; seconded by Grant. All ayes.
5. Roberts moved to go into closed session referencing the statute cited in §3 above; seconded by Grant. All ayes.

 - 6.1. Five candidates for full-time Firefighter/Paramedic were interviewed in closed session. A ranked list of the candidates was provided to Chief Stien.
 - 6.2. From the ranked list of four full-time Firefighter/Paramedic candidates interviewed on October 16, 2025, one was disqualified, one has expressed interest in remaining under consideration, and two have not indicated interest in remaining under consideration.
 - 6.3. Grant moved to approve change in status of Savannah Salentine and Jason Schroerer from Cadet to probationary part-time POP/POC; seconded by Roberts. All ayes.
 - 6.4. Dubey moved to approve Madisyn Healy for reinstatement as part-time POP/POC; seconded by Grant. All ayes.
 - 6.5. Roberts moved to approve recommendations of Adam Bowden, Jacob Brown, Caleb Eide, Austin Elgar, Emma Ellis, Hanna Haataja, Cheryl Lang, and Joseph Totzke for part-time POP/POC positions; seconded by Grant, Passed unanimously.
7. The next Commission meeting will be in July, date to be determined.
8. Roberts moved to adjourn at 8:10 pm; seconded by Grant. All ayes.
